Center for America Senior Fellow Bob Dorigo Jones is a leading spokesperson about abuses in the civil justice system and what we should do about them. For two decades, he has focused on educating the public about how families, communities, and job providers are hurt by out-of-control lawsuit abuse.

Bob's weekly radio program, "**Let's Be Fair!**," is broadcast by 83 radio stations across America, including Eagle Broadcasting and Cumulus. It also is featured on major websites, such as Tucker Carlson's DailyCaller.com.

Bob is the creator and host of CFA's annual Wacky Warning Labels™ Contest, now in its 15th year. Through this contest, which highlights the lengths to which companies must go to try to protect themselves from frivolous lawsuits, more than 180 million Americans learn about the absurdity of lawsuit abuse. Entries are sent in by people around the United States from which "the wackiest" are selected for final judging in June by a live audience on John Stossel's national television show on Fox Business.
